COVID-19 Recovery Grant

As the COVID-19 pandemic spread across the globe, the Forbeck Foundation struggled to figure out how we can remain relevant in a time where conferences, meetings and even small gatherings were forbidden. At the first ever virtual Retreat in October 2020, we could hear how much the junior scientists were struggling across the globe from the shutdown.

"The COVID-19 outbreak caused many academic labs to either close or curtail their activities significantly, with animal colonies lost and reagents expiring due to the inability of the investigators to use them in a timely fashion. COVID is going to impact the direction of science for some time to come. Most of the funds earmarked for cancer research have been redirected to focus on COVID-19. Cancer research will still continue but it will be a second-class citizen at least until times get back to 'normal'."

Inspired by discussions with the Forbeck Scholars, the Strategic Planning Committee proposed the Forbeck COVID-19 Recovery Grant. The Foundation was able to redirect funds from the rescheduled 2020 meetings to help these junior researchers get back to fighting cancer. Wasting no time, the Forbeck Foundation opened applications for junior researchers to request up to \$30k in funding to be directed towards things lost during the shutdown. In January, the Scientific Advisory

Board awarded over \$283k in grants to 13 Forbeck Scholars. Most requests had to do with reagents lost, mice colonies that had to be exterminated, or the increased costs of supplies or loss of funding during the global struggle. The awardees were incredibly grateful for this opportunity.

"As a consequence of the pause to in-person benchwork, supplies that I use for single-cell transcriptomics expired and mice which were to be used for patient-derived xenografts (PDX) were culled. These specialty reagents... are very costly and as a result we lost nearly \$24,000 in single-cell RNAseq supplies alone..... I greatly appreciate the opportunity from the William Guy Forbeck Research Foundation to recover some of these lost research supply costs and the recognition of the significant disruption the pandemic has had on our work."

"As a result of COVID-19 an unexpected pause occurred in my telomere research, which prevented me from gathering data critical to the development of my research program. The requested funds from this grant award will provide a bridge to support costs to finalize pending experiments while supporting the continuation of my telomere research program, which is currently unfunded as a result of COVID-19. Specifically, the funds requested in the attached budget will be used to pilot a 'chromatin conformation capture' based assay that can detect telomeric chromatin interactions using DNA sequencing."
